## Welcome to TSG Siegen!

We welcome you as a new member and offer you the club-standard "DU".

We hope that by joining our wide range of offers you will have found a department that corresponds to your sporting ambitions and in which you feel at ease both athletically and personally.

Here is some information in connection with the club membership: Membership can be terminated with a notice period of 6 weeks to the end of the year. The notice of termination must be given in writing to the board of the association.

The fee for young people is € 5.00 and for adults € 7.00 per month (from 1.1.2022). The collection of contributions takes place either quarterly, half-yearly or annually in advance. There is a one-time registration fee of € 5,00. Payment is made by direct debit. Family contributions can be requested from the board of directors. If additional fees are charged in individual groups, the respective instructor will provide information. In the badminton department, the money for the shuttle cocks is currently € 1,50 (up to 14 y.) / € 2,50 (up to 18 y.) / € 5,00 € and is collected with the club fee.

As part of the sports aid scheme, every member is additionally insured against accidents that may occur during the sports activities of the club. The contributions to sports aid are already included in the membership fees. If a sports accident should occur during the practice hours, the trainer is responsible for reporting the accident to the office immediately.

TSG Siegen holds its sports lessons in various gyms in the city of Siegen. We have no influence on the condition of the gyms, the sports equipment and sanitary facilities available there. However, we assume that our members treat the gyms and their facilities with care and leave them as clean as they wish to find them.

Gyms are unfortunately popular objects for "thieves" and it is almost impossible to protect changing rooms against unauthorized intruders. Therefore, please never leave valuables in the changing rooms, but take them with you into the training area.

## Request for information in accordance with Article 15 GDPR



Dear club member,

We process the following personal data about you for the following purposes:

- Your personal data will be processed for the implementation of the membership
  relationship in the club as well as in the context of participation in the game operations of
  the associated regional professional association.
- 2. We process the following personal data about you:
  - a. Gender
  - b. First name. Last Name
  - c. Date of birth
  - d. Address (street, house number, zip code, city)
  - e. Email address and telephone numbers (landline and mobile number)
  - f. Date of joining the association
  - g. Department and team affiliation
  - h. Bank details (IBAN)
  - i. Sporting activities
- 3. These data (with the exception of i.) are collected directly as part of the admission procedure.
- 4. The categories of data relating to your person: Gender, first name, surname, date of birth, address, date of joining the club, sporting activities are forwarded to the regional professional associations for the purposes of licensing and in the context of gaming operations.
- 5. Your bank details will be forwarded to Sparkasse Siegen for the purpose of direct debit together with your name, the purpose and the amount due.
- 6.1. Upon termination of membership, the data categories 2.a. to c. and f. held for a further ten years in accordance with the statutory retention periods and then deleted. In the period between membership termination and deletion, the processing of this data will be restricted. The data of the other categories will be deleted upon termination of membership.
- 6.2. The data categories b., G. and i. are stored in the club archive for the purpose of club history. The storage is based on a legitimate interest of the association in the historical archiving of the composition of the teams.
- 7. You have the following rights under the conditions stated in the respective articles: the right to rectification in accordance with Article 16 GDPR, the right to erasure according to Article 17 GDPR, the right to restriction of processing in accordance with Article 18 GDPR, the right of objection according to Article 21 GDPR, the right to lodge a complaint with a supervisory authority in accordance with Article 77 GDPR.

If you send us your request for information electronically, we will send you the Information in accordance with Article 15, Paragraph 3, Clause 3 of the GDPR as an attachment in PDF format.
